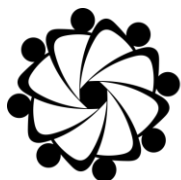

The blanks acquired along proficiency tests DO NOT belong to the same batch from which the PT samples are prepared.

## HOW TO START WORKING TESTQUAL?

If you want to participate in our PT or acquire material, you must create an account on our website, you can follow the following steps:

2. You must complete the required information (laboratory name, VAT, contact information, etc.).





3. Once registration is complete, the website administrator will notify you by email when your account has been activated.
4. Once the account is activated, you can log in with your credentials and request any proficiency tests and/or material you need.
5. In case any additional information is necessary, the **TestQual** team will contact you.

## HOW TO REGISTER FOR AN PROFICIENCY TEST?

1. Check out the proficiency tests available at [https://www.testqual.com/proficiency\\_tests/?anio=2025](https://www.testqual.com/proficiency_tests/?anio=2025).
2. By clicking on the shopping cart of a proficiency test you will access the page with information regarding it.
3. The proficiency test page contains the instructions in PDF format (right column) and at the bottom and top of the web page you can start your request to participate by clicking on the "Participate" button.

Our team can add proficiency tests to your client area and save you time, all you must do is send us your quantification limits\* or tell us which group of available analytes they will analyse.

\*By sending us your data you accept the conditions of participation.

4. Log in.
5. Select the matrix(es) available for the proficiency test and indicate the limit of quantification of the proficiency test parameters that your laboratory studies and that you want to be quoted.

During registration you will find help tools at your disposal to make it easier for you to enter your data (Load quantification limits from past participations or apply the same quantification limit to all parameters).

Analytes left as Not Analysed (NA) will not appear when you send the results (they will not be requested).

6. When you accept, a screen will appear for you to verify that the data entered is correct. After confirming it, the registration will be completed.
7. The website administrator will review your participation request to ensure the participation will be useful for your and in less than 48 hours, if you are not requesting any further information, you will receive an email with your laboratory code, confirming your participation.

By accessing your customer area, you can check that the participation request has been sent satisfactorily and, if it is pending review or has already been assigned a laboratory code.
